AGENDA POSTING

Buddy did mention that on the call part there really isn't that many at night and it would not be a full-time job for Sonya to be running to the clinic at night. Wesley Bean asked if Sonya was going to work Monday through Thursday every week and Mr. Henderson stated Marcus would take some call as well but would quit working weekends. Mr. Henderson did announce the ambulances are getting a lot of miles on them.
