**Tara Carey was present to state that she was wanting to write a grant for Constable Patrol Unit Project for the Constable's Office in the amount of \$75,000.00. Mike Medina made a motion to allow Tara Carey, Constable to apply for the Grant. Elsa Fierro seconded, all in favor. Motion carried.**

### **OPEN FORUM/PUBLIC COMMENTS**

**Willie Williamson was present to address the Court with several issues that he sees around town. First issue was the Care Center Van that is driven to San Angelo and most of the time it has one resident or two with the driver and CNA. He thinks it's a big van for just a few people and would like to see something smaller that would fit wheelchairs as well. The second issue was the new**

paving project the County contracted to have streets in town paved and there is a bunch of loose gravel/rock. Jeffrey Stuart announced the paving job didn't go quite as good as the citizens wanted but it is 100% guaranteed and the company is working on correcting issues. Third issue he addressed the Court with were Stop Signs. He mentioned people were using them as yield signs including County workers and Water Department Workers. Judge Tambunga stated he would mention it to local authorities. The fourth issue is he is worried about the Crime in town in which a puppy has been put outside to tend to business and he gets stolen.

Jeffrey Stuart was present to inform the Court that he wants to buy a new metal building for the Cemetery Workers and he has priced them. He mentioned his cemetery workers do not have a decent facility to park riding mowers, store equipment and keep things from getting stolen. Being able to do this the workers would also have a decent place to have their lunch and take their breaks.

Judge Frank Tambunga also stated that he is going to apply for a Grant from COG to assist with some debris and trash clearing for our town.
