Victor Uvalle with TAC was present to address the Court about Risk Management Services & Training that TAC provides.

# EXAMINATION OF ACCOUNTS FOR APPROVAL AND DIRECT PAYMENT OF THOSE APPROVED "EXHIBIT A"

The Court met to examine accounts for approval and direct payment of those approved on Treasurer's Claim Register. Wesley Bean made a motion to pay bills as presented. Elsa Fierro seconded, all in favor. Motion carried.

CONTRACT PROPOSAL FROM SECURITY SOLUTIONS CENTER FOR SENIOR CENTER DOORS "EXHIBIT B"

#### CONTRACTING WITH CIVIC PLUS SOCIAL MEDIA ARCHIVES

Judge Tambunga and Eddie Martin have been visiting with a gentleman that will help put together a social media policy due to new law passing making County entities subject to Open Records Act. This company would capture everything typed into the site. If a comment is deleted it could still be pulled up through the archive system. This agenda line item will be tabled until Judge Tambunga talks to the Technology Committee and Victor Uvalle with TAC Risk Management Consultant checks into it.

She stated in Order to get PTO there is a scale they go by depending on the years of service to the County.
