UNCLAIMED PROPERTY CAPITAL CREDITS FOR COUNTIES "EXHIBIT M"

This is in conjunction with LGC, Section 381.004, Texas Property Code, Section 74.602 authorizes the Texas Comptroller of Public Accounts (Comptroller's Office) to allocate a portion of the unclaimed capital credits received from electric cooperatives back to the counties in the cooperatives' service area. Judge Tambunga announced the Court did this last year and received a little over \$2,000.00 and the County used it install the library alarm system. Elsa Fierro made a motion to submit the unclaimed property capital credits for Counties. G L Bunger seconded, all in favor. Motion carried.

CONSIDER APPROVAL AND DISCUSS REDUCING SPEED LIMIT ON AVE D IN FRONT OF OZONA HIGH SCHOOL
