Emily Guerra was present to inform the Court about the maintenance contract for the elevator at the museum has terminated. She has talked to Home Elevators the company that originally installed the elevator at the museum about servicing the elevator and their charge is \$825.00. AUTHORIZATION TO ISSUE REQUESTS FOR PROPOSALS (REPs) FOR ADMINISTRATIVE SERVICES AND REQUEST FOR QUALIFICATIONS (RFQs) FOR ENGINEERING SERVICES RELATED TO THE 2025 COLONIA FUND CONSTRUCTION (CFC) ADMINISTERED BY THE TEXAS DEPARTMENT OF AGRICULTURE (TDA) Samantha Chumley was present to discuss this proposal with the Court. Wesley Bean made a motion to issue requests for Proposals REPs, RFQs for Engineering Services related to the 2025 Colonia Fund Construction administered by the Texas Department of Agriculture.
