### **APPROVAL AND DISCUSS HIRING MONA LISA RUDD, M.A., M.S., LNFA FULL TIME AS THE CROCKETT COUNTY CARE CENTER ADMINISTRATOR AS RECOMMENDED BY THE HEALTH SERVICES BOARD**

Wesley Bean made a motion to hire Mona Lisa Rudd, M.A., M.S., LNFA full time as the Crockett County Care Cener Administrator as recommended by the Health Services Board. Elsa Fierro seconded, all in favor. Motion carried.
