MAKING A CHANGE TO THE 2025 HOLIDAY SCHEDULE FOR THE CHRISTMAS HOLIDAY

No action taken on this agenda line item at this time.

RESOLUTION IN DESIGNATING A SECTION OF STATE HIGHWAY 163 AS A MEMORIAL DESIGNATION TO HONOR THE CROCKETT COUNTY VETERANS WITHIN JURISDICTION OF CROCKETT COUNTY "EXHIBIT L"

Judge Tambunga stated he checked with TXDOT on this matter to see what needed to be done and he was told to pass a resolution. The area designated for the Veteran's Memorial Highway is the section of SH 163 within Crockett County, specifically from Intersection on NH 163 and 1st Street to the Intersection of South Hwy 163 and Chandler Road. Elsa Fierro made a motion to approve the Resolution of the Crockett County Commissioners Court Designating a Section of State Highway 163 as a Memorial Designation to Honor the Crockett County Veterans within the Jurisdiction of Crockett County. G L Bunger seconded, all in favor. Motion carried.

MOVING FORWARD WITH THE REMOVAL OF THE EMERALD HOUSE

Jesus Najar with Preservation Texas visited with the Court via Zoom about options to consider for the Emerald House. Jim Fish and Jefferson Spillman made the call and spoke with Mr. Najar about this project. Wesley Bean stated he will donate the \$500.00 to have Preservation Texas come to Ozona and examine the Emerald House and submit a report. Wesley Bean made a motion to give Preservation Texas a chance to provide a report by June 1, 2025 and if the Court doesn't receive anything by that date they will proceed with the demolition. G L Bunger seconded. Mike Medina voted against.

OPENING A POSITION AND HIRING A PERSON TO BE A GRANT WRITER "EXHIBIT M"

Judge Tambunga announced if the County hires its own grant writer it would help Laura Conner, County Treasurer and Stephanie Galindo, Sheriff's Office Administrator a lot, plus the County would take advantage of more grants available. The County is paying Michelle Martinez with Grant Works approximately \$48,000.00 a year. Elsa Fierro made a motion to start the process to open a position and hire a person to be a Grant Writer for the County. Wesley Bean seconded, all in favor. Motion carried.

APPROVAL AND DISCUSS APPLYING FOR SB-22 PROSECUTOR GRANT BY OUR DISTRICT ATTORNEY

Stephen Dodd, 112th District Attorney informed Judge Tambunga he would like to apply for the SB-22 Prosecutor Grant and the deadline is January 31, 2025. Mike Medina made a motion to allow the District Attorney to apply for SB-22 prosecutor grant. Wesley Bean seconded, all in favor. Motion carried.

APPROVAL AND DISCUSS THE PURCHASE OF CABINETS FROM SOUTHWEST SOLUTIONS GROUP "EXHIBIT N"

Ninfa Preddy, County Clerk stated she needs the Court's permission any time she wants to use funds from the Records Management Account. Wesley Bean made a motion to allow the purchase of the cabinets to be paid out of Records Management Account. Elsa Fierro seconded, all in favor. Motion carried.

APPROVING RESOLUTION TO ALLOW SHAMROCK ENERGY STORAGE TO COMMENCE TAX ABATEMENT "EXHIBIT O"

Judge Tambunga stated the last time this was brought up they forgot to send in the letter to start the abatement and the County collected approximately \$49,000.00 from the Shamrock Energy Storage. This year the same thing happened on the battery abatement. The Court would like to review the abatement and will take no action at this time on this agenda line item.

COUNTYWIDE BURN BAN

Mike Medina made a motion to put in place the CountyWide Burn Ban. Elsa Fierro seconded, all in favor. Motion carried.
